INSTRUCTOR, JOANNA PAZ-MOLESKY began dancing at Berkeley Ballet Theater in 1991. She co-founded En Pointe Youth Dance Company in 1999, initiated and organized its Mexico summer immersion trip in 2005, and directed the company through 2006. In 2008, she founded JUNTOS, an organization committed to uniting performing art and social justice, and in 2009 directed an intercultural exchange for JUNTOS in Mexico. She is currently in her fourth year in The Ailey School/ Fordham University's BFA dance program.

Dancers will explore structural and creative techniques to strengthen dance composition. The workshop begins with choreography exercises for solos and, later, group pieces. Participants are introduced to various concepts including A and B phrases; Motifs vs. Design; Theme and Variation; Manipulation; among others. We will discuss how to incorporate improvisation, musicality, and spacing in dance composition. The workshop will culminate with a choreography showing of student work.
